GIFTED IDENTIFICATIOn: Definition

"Gifted" means students who perform or show potential for performing at remarkably high levels of accomplishment when compared to others of their age, experience, or environment and who are identified under Section 3324.03 of the Ohio Revised Code.

The Identification Steps:

A student is considered screened for gifted identification when he or she is evaluated using an instrument approved for gifted identification. Bryan will evaluate students referred or recommended for gifted identification and provide opportunities for evaluation during whole-grade screenings.

How are children identified in Ohio?

Ohio law requires each school district to identify gifted students K-12 in the following areas:

Superior Cognitive Ability
Specific Academic Ability:

Creative Thinking Ability
Visual & Performing Art:

Reading Math

Dance Drama Music

Visual Arts

Referrals: Parents, teachers, or peers may refer students for gifted identification evaluation. Students may also refer themselves. Once a school or district receives a referral or recommendation for the evaluation of a student, they must test within ninety days of the referral. Districts are required to provide two opportunities per year for the evaluation of students in grades K-12 who are referred for identification in any area of gifted ability. Referral forms are available in the school offices.

Whole-Grade Screenings: Bryan City Schools will provide the following whole-grade screenings:

- 2nd Grade: Superior Cognitive, Creative Thinking, and Specific Academic- *Reading or Math*
- 5th Grade: Superior Cognitive, Creative Thinking, and Specific Academic- *Reading or Math*
- I-Ready: Grades 2-9

Assessment strategies: Assessments provide additional data necessary for an identification decision and the delivery of services. Strategies for additional assessment include the individual and group testing requirements of Sections 3324.01-3324.07 of the Ohio Revised Code. Once school personnel have completed the assessment, the data obtained throughout the stages of identification is evaluated and the identification decision is made and the student's educational needs are determined. Parents will be notified of testing results within 30 days of the district receiving the scores.

Special Populations

The district does not discriminate and ensures that special populations are included in screening and assessment procedures. Appropriate instruments are used to ensure that children who are culturally and linguistically diverse (minority and/or children who are limited English proficient, children from low socioeconomic status, and children with disabilities) are included.

General and Transfer Students

The district accepts scores on assessment instruments approved for use by the Ohio Department of Education provided by other school districts and/or trained personnel outside the school district. The district ensures that any child transferring into the district will be assessed within 90 days of the transfer at the written request of the parent.

Appeal Procedures

Parents have an opportunity to appeal any decision about the results of any screening procedure or the scheduling of children for assessment, or the placement of a student in any program for the receipt of services.

An appeal by the parent is the reconsideration of the results of any part of the identification process that would include:

- Screening procedures or assessment instrument (which results in identification);
- The scheduling of children for assessment;
- · The placement of a student in any program; and
- Receipt of services.

Parents should submit a letter to the superintendent or building administrator outlining the nature of the concern. The superintendent or building administrator will convene a meeting with the parent/guardian, and may include other school personnel. The superintendent or building administrator will issue a written final decision within 30 days of the appeal. This written notice should include the reason for the decision(s).
